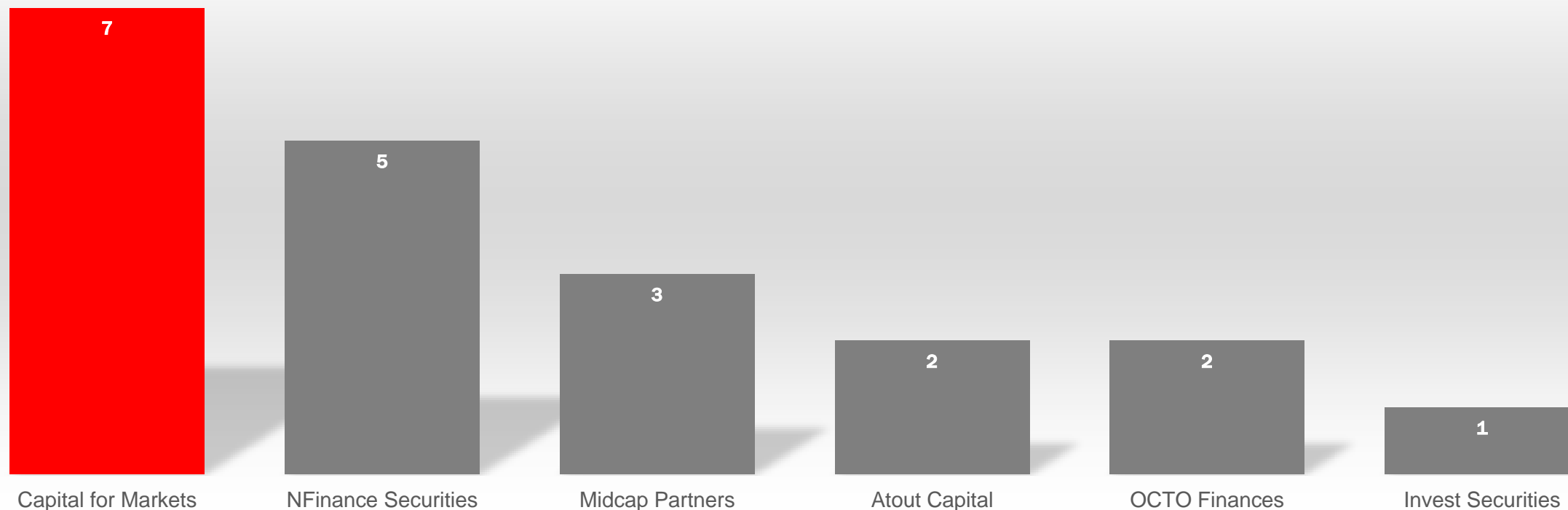
Between January 1st and October 20th 2015, 20 Going Publics took place on the Marché Libre segment, the non-regulated market segment of Euronext Paris.
